Policy Passed: Sun Safety | Outdoor Recreation and Outdoor Worksite

Rationale:

Skin Cancer is the most common cancer in the United States. Exposure to ultraviolet (UV) radiation in sunlight causes nearly all skin cancer cases. The risk for skin cancer can be greatly reduced when certain precautions are practiced. Therefore, Great Sacandaga Brewing Company is committed to promoting sun safe practices to patrons visitors and employees and will implement the following sun safety policies.

Policy |Sun Safety |Outdoor Recreation

Great Sacandaga Brewing Company will promote basic personal strategies for preventing skin cancer for patrons and visitors.

Wear sun-protective clothing

When appropriate, Great Sacandaga Brewing Company will encourage patrons and visitors to wear sun protective items such as long sleeves, long pants, wide brimmed hats and sunglasses to practice sun safety while participating in outdoor recreation activities. When affordable, on site apparel promotions will include long sleeve products.

Carry and use sunscreen with a minimum of SPF 15

When appropriate, Great Sacandaga Brewing Company will encourage patrons and visitors to apply sunscreen with a minimum of SPF 15 applying it to all exposed areas of the skin. A sunscreen dispenser will be provided and maintained for patrons and visitor use.

Seek shade when outside in the sun

When appropriate, Great Sacandaga Brewing Company will make shade available for patrons and visitors in high-use recreation areas and encourage patrons and visitors to seek out shaded areas.

Reduce exposure to sunlight between 10AM and 4PM, when feasible

When possible, Great Sacandaga Brewing Company will plan outdoor activities to be scheduled before 10AM or after 4PM from April through October. Availability of shade will be considered when scheduling planned outdoor activities during these time frames.

Sun Safety Education Entertainment

When possible, Great Sacandaga Brewing Company will provide sun safety education to paid entertainment including musicians who may visit the site to perform for patrons and visitors.

Sun Safety Verbal Communication

When possible, Great Sacandaga Brewing Company will encourage patrons and visitors to practice basic personal strategies for preventing skin cancer through on-site verbal communication at strategic locations of high UV radiation exposure. For example: patio,deck and lawn areas.

Sun Safety Written Communication

When possible, Great Sacandaga Brewing Company will encourage patrons and visitors to practice basic personal strategies for preventing skin cancer through on site written communication at strategic locations. For example: signage in high use areas, website, newsletters and social media.

Great Sacandaga Brewing Company will promote basic personal strategies for preventing skin cancer for employees while they are on duty.

Wear sun-protective clothing

When appropriate, Great Sacandaga Brewing Company will encourage employees on duty to wear sun protective items such as long sleeves, long pants, wide brimmed hats and sunglasses to practice sun safety while working outside.

Carry and use sunscreen with a minimum of SPF 15

When appropriate, Great Sacandaga Brewing Company will encourage employees to apply sunscreen with a minimum of SPF 15 applying it to all exposed areas of the skin while working outside. For example: Back of hands, neck and ears. Great Sacandaga Brewing Company will provide sunscreen of SPF 15 or higher for employees and encourage reapplication of sunscreen every two hours while working outside.

Seek shade when outside in the sun

When appropriate, Great Sacandaga Brewing Company will make shade available for patrons and visitors in high-use recreation areas and will encourage employees to seek out these shaded areas while on duty.

Reduce exposure to sunlight between 10AM and 4PM, when feasible

When possible, Great Sacandaga Brewing Company will plan outdoor activities to be scheduled before 10AM or after 4PM to reduce the strongest daily UV radiation exposure to employees. Availability of shade will be considered when scheduling planned outdoor activities during these time frames and employees will be encouraged to seek out shade and/or apply sunscreen while on duty.

Sun Safety Education

When possible, Great Sacandaga Brewing Company will provide sun safety education yearly to all employees at hire or during new employee orientation training sessions. Including paid entertainment. For example, musicians who may visit the site to perform for patrons and visitors.

Sun Safety Verbal Communication

When possible, Great Sacandaga Brewing Company will encourage employees to practice basic personal strategies for preventing skin cancer through on-site verbal communication at strategic locations. For example: patio,deck and lawn areas.

Sun Safety Written Communication

When possible, Great Sacandaga Brewing Company will encourage employees to practice basic personal strategies for preventing skin cancer through on site written communication. For example: signage in high use areas.
